You are invited to attend the annual conference for student council advisers in Albuquerque, beginning at 2:30 pm on September 20 & ending at 3:30 pm on September 21. It will be a great opportunity to share ideas, learn how others do their jobs, and hear experts on advising student council. We are privileged to have Bob Tryanski as our keynote speaker. Bob 'knows' student council from the grass-roots at mid-school to the national scene. We really hope that you will attend.

We have corporate support and support from NMASSP and the NMAA for the conference at a nominal cost to you or your district. The cost is a registration fee of \$35.00 per person, including meals and conference expenses and a double-occupancy hotel room (you will be assigned to a room with another adviser.) unless you wish an optional rooming arrangement (see options below). You or your school is responsible for all travel and any meals en route to and from the conference.

The proposed agenda will include: sessions for high school advisers, middle-level advisers, and new advisers; student council elections; character-building; fund-raising; diversity in student council; team building; beginning-of-year planning; incentives for officers; commitment, resources, and networking; fund-raising, especially on-line; and working with the school principal.
